## Military Road Recommendations To Be Presented at Next DRCA Meeting

The results of the Arterial Transportation Management (ATM) Study that pertain to Military Road will be presented by Richard Best, staff liaison to the county's ATM Study, at the Donaldson Run Civic Association (DRCA) meeting on Tuesday, September 14. Military Road was one of 11 streets evaluated as part of the year-long study, and in July the county's Transportation Commission unanimously endorsed the recommendations of the ATM Task Force.

The purpose of the ATM recommendations is to enhance the safety and efficiency of travel by all users of the road including pedestrians, bicyclists, transit users and motorists while taking into account the context of the surrounding land use. Methods such as lane narrowing, adding medians, widening sidewalks, and adding safe crosswalks are some of the recommendations that were made for Military Road. At the September membership meeting, DRCA would like to get members' input about these recommendations and decide which the association will pursue with the county.

Please note that the September meeting will **not** be at Taylor School, but will be in Fellowship Hall at the Church of the Covenant located at 2666 Military Road.

# County Solicits Advice On Placement of New Traffic Signals

The county board recently approved funding for a new traffic signal initiative in Arlington as part of the fiscal year 2005 budget, which began in July. The purpose of this \$1 million initiative is to install five new signals at intersections with high pedestrian and vehicular traffic.

The county is soliciting suggestions as to where the new lights should be installed. Following receipt of all requests, county staff will evaluate each location based on intersection conditions and traffic counts. Priority will be given to intersections with a high volume of pedestrian and vehicular traffic, proximity to schools, accident experience, and other measures. Based on this analysis, staff will recommend to the county board the five locations for traffic signal installation. It is our intent to announce the five chosen intersections before the end of the year, with work to commence with the community in 2005.

Thus far, the following locations in Donaldson Run have been suggested for a new traffic light:

- \* Pedestrian activated light on Lorcom Lane at Vacation Lane
- \* Old Dominion Drive at 26th Street
- \* Military Road and 26th Street on the north side of Military Road
- \* Military Road at 30th Street (or at the entrance to Zachary Taylor Nature Area)

# **Military Road Bridge Construction Update**

Phase I construction of the Military Road bridge will be completed in approximately thirty days, according to Edward Sanders, the construction manager. The remaining work in phase I construction consists of precast culvert placement on the north side, backfill, roadway construction, Dominion Power pole relocations and traffic shift from the south side of Military Road to the north side.

Phase II construction will be completed approximately thirty days following phase I. The work will consist of roadway and foundation excavation, placement of culvert foundation, placement of precast culvert sections, culvert backfill, roadway construction and restoration. The completion date for the entire project is projected to be October 2004.

## **DRCA's Next NCAC Project - Restoration of Tributary B**

The parks in our neighborhood are very important to us, as DRCA learned from the survey it used to prepare Donaldson Run's Neighborhood Conservation Plan in 1999. There has been a lot of excitement over the restoration of Tributary A of Donaldson Run which is scheduled to begin this fall. As a result, DRCA's executive committee has decided to move ahead with the restoration process on Tributary B in Taylor Park.

Tributary B runs from the confluence of Tributary A up to the mulch pile. Details of this proposed project will be given at DRCA's September membership meeting. A vote will be taken to determine whether to advance this project as

Donaldson Run's number one priority for the Fall funding round of the Neighborhood Conservation Advisory Committee (NCAC).

Due to money limitations, the county may not be able to fund the entire stretch of Tributary B as one project. Instead, DRCA may need to divide the project into two or more parts and fund them separately. Come to the September meeting to learn more about the restoration of Tributary A and our plans for Tributary B of Donaldson Run.

## **Application for Park Enhancement Grant**

The Donaldson Run Civic Association (DRCA) has applied for a Park Enhancement Grant (PEG) to install two stone benches near the bike path below North Vermont Street. The benches would serve park visitors using the bike path that starts at Military Road, crosses North Vermont Street, and ends at North 26th Street, opposite Marymount University. A flagstone walk would be installed to provide all-weather access to the benches, and trees would be planted to provide shade in summer.

The bike path follows Donaldson Run upstream from Military Road -- a long, steady climb. There are no benches between Military Road and North Vermont Street, so the benches to be installed under this project would be the first opportunity to rest. With seating space for several people, the benches would also provide a convenient place for park visitors to meet and talk.

A survey of Donaldson Run households a few years ago indicated that some eighty percent of residents visit neighborhood parks on a regular basis. Many of these park visitors follow the bike path along Donaldson Run where the benches would be located.

The rustic stone benches would blend with the park's natural setting, a setting that will be enhanced by a nearby stone wall to be built under a Neighborhood Conservation project. 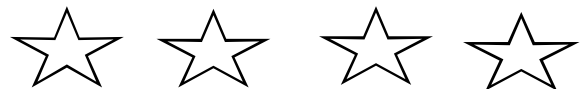

# Donaldson Run Stream Restoration Project

For about two years, we have been reporting on plans for a major stream restoration project along Donaldson Run in Lee Heights and Zachary Taylor Parks. Now this work is about to begin.

The project is needed because of serious erosion along Donaldson Run. Stormwater falling on impervious surfaces flows rapidly into storm sewers and then into streams. Present stream configurations cannot handle these surges of stormwater without suffering from erosion.

Runoff destroys habitat for stream organisms and carries sediment and other pollutants downstream to the Potomac River. Erosion threatens trees and trails along the stream, and it has also led to some breaks in sanitary sewer lines.

The early phases of the stream restoration project began in August 2003, with data collection and a survey of the streambed. As the work progressed, a community workshop was held on November 12, 2003, to review conceptual plans for the project. Residents had an opportunity to learn more about the project on a stream walk a few days later, on November 15, 2003. A second community workshop was held on February 25, 2004.

During the past winter and spring, a stream restoration advisory group met several times with the stream consultant to work out the details of the project. Members of the group include Donaldson Run residents and county staff. Because this project has implications for future projects elsewhere in Arlington, the advisory group also includes representatives of the Urban Forestry Commission, the Park and Recreation Commission, the Environment and Energy Conservation Commission, and Arlingtonians for a Clean Environment (ACE).

The project design is nearing completion, and construction is expected to begin before the end of 2004. Park users should be aware that extensive earthmoving will be required to create a stable stream channel through Lee Heights and Zachary Taylor Parks. Construction is expected to take about three months, and the nature trail through

Zachary Taylor Park will be closed for safety reasons. It may also be necessary to close the bike path along the left bank of the stream for brief periods.

Relocating the stream channel will require removal of a substantial number of mature trees. To replace those trees, several hundred canopy and understory trees, together with shrubs and ground cover, will be planted after construction has been completed. The stream restoration advisory group has been developing a planting list which includes a variety of native trees and shrubs selected for their compatibility with the sites and their wildlife habitat value.

The stream restoration project will be discussed at the DRCA meeting on Tuesday, September 14. To be better prepared, Arlingtonians are invited to attend the free Arlington Prepares Fair on Saturday, October 30 at the Arlington Career Center, 816 South Walter Reed Drive.

Arlington's Office of Emergency Management, Arlington Citizen Corps Council and other partner organizations will offer free information to help you prepare for and recover after an emergency. Arlington County also will provide a display of a variety of emergency equipment, including the new Mobile Command vehicle and the County's specialized HazMat equipment.

At 1:15 p.m. participants will work through a simulated emergency scenario to demonstrate the community's preparedness and to discuss appropriate responses for the emergency scenario. The exercise also will explore communication and coordination among county agencies, volunteer organizations and the public during an emergency. While this is principally an exercise to benefit Arlington County and its partner organizations, the public is welcome to observe and participate.

Attendance is free and registration is not necessary. The Arlington Prepares Fair is sponsored by Arlington County Office of Emergency Management and the Citizen Corps Council.

## **Marymount University's Master Plan**

Marymount University recently completed its Campus Facilities Master Plan. The plan was developed during the 2003-04 academic year and was endorsed by the University's board of trustees in December 2003. Last spring, Dr. James Bundschuh, the President of Marymount University, presented the plan at a Donaldson Run Civic Association (DRCA) meeting.

The objectives of the plan include expanding student housing and activity space, adding an academic building in the center of the campus, separating pedestrian and vehicular traffic, and creating more green space. Of particular interest to the Donaldson Run community is the proposal to build a three story parking garage on the site of the current 26th Street parking lot. The University has indicated that the plan for the garage will be "an aesthetically pleasing structure that appropriately blends with and enhances the surrounding neighborhood." At the civic association meeting, neighbors expressed their desire to have the garage sited underground as much as possible, and it was recommended that the entrance and exits of the garage be on Yorktown Boulevard. Plans for the proposed garage will need to go through the usual county process which allows for community input. Dr. Bundschuh advised that he would keep DRCA notified as the University's plans for the parking garage progress.

## **New Laws for Virginia Drunk Drivers**

Did you know that an alcohol-related fatality occurs approximately every 30 minutes, making it the nation's most frequently committed violent crime? More than 17,000 people in the U.S. die in alcohol-related crashes every year. On average, a person is injured in an alcohol-related crash every two minutes.

In response to the public's outcry over drunk driving, Virginia has enacted new laws that are considered among the toughest in the country. Starting on July 1, 2004, an increased focus is on repeat offenders and harsher penalties. The laws establish new mandatory jail sentences, allow courts to confiscate vehicles, and impose additional fines. At the time of an arrest for Driving Under the Influence (DUI), law enforcement officials will report the offense to the Central Records Exchange - thus, drunk driving violators will have criminal records.

In the coming weeks and months, Arlington police officers and Sheriff's deputies will continue their implementation of concentrated DUI enforcement operations as part of this year's regional Checkpoint Strikeforce campaign. There will be sobriety checkpoints as well as specific DUI patrols looking for drunk drivers.

It is estimated that, after all of the associated fees, fines, rate increases, towing charges, and other expenses are added up, a DUI arrest in Virginia costs more than \$5,500. If you decide to consume alcohol, the best way to avoid this expense is to have a designated driver or take a cab.

## **Residents Can Reduce Air Pollution**

(originally published in **The Arlington Environment, Summer 2004**)

We know the air quality is bad in this area, but what can we do about it? Many people believe that the bulk of air pollution comes from industries, but in the Washington, DC area, individual resource consumption and practices create far more pollution than industries. In fact, motor vehicles account for about 30 to 40 percent of the ozone-causing pollutants in the Washington region.

There are many actions we can take that will help. Minimizing contributions to air pollution is even more critical on code-red days when ozone levels are high.

Besides emissions from motor vehicles, other less obvious sources of air pollutants include oil-based paint and emissions from gasoline powered lawn and garden equipment.

Some of the most important actions we can take:

- Reducing car emissions by carpooling, telecommuting, taking mass transit, and combining your errands;
- Biking or walking instead of driving;
- Refueling all vehicles after dusk;
- Minimizing use of lawn and garden equipment or using the equipment after dusk;
- Postponing use of aerosols; and
- Postponing use of oil-based paints.

In your workplace, ask if your employer is part of the Ozone Action Day Employer Program, an outreach program sponsored by Clean Air Partners. More than 250 companies, government agencies, and educational institutions are part of the program. Through this free program, employers receive notices of ozone action day forecasts. Participating employers also receive educational information to share with their employees about air pollution and how individuals can help. # Fort Ethan Allen Community Canine Area Relocation Task Force

The Arlington County Board created the Fort Ethan Allen Community Canine Area (FEA CCA) Relocation task force in January 2004. The task force was charged with recommending to the county board a permanent site for the current CCA, which is located within the historic district along Old Glebe Road. The task force was composed of representatives of the civic associations along Military Road, and various community groups representing dog park users, park advocates, and members of the historical community. In addition to serving as the Donaldson Run Civic Association representative, I was appointed chair by the county board.

After considering approximately 35 sites, the task force voted 15-1-2 in favor of the "yellow site" located along North Stafford Street adjacent to the Madison Community Center. Recognizing that no site would be perfect, task force members chose this site for many reasons including the flat terrain, existing parking lot, preservation of trees, and perceived cost. This recommendation was endorsed by the Arlington County Manager and was adopted by the county board on June 26, 2004, by a vote of 4-1. The design and construction period is expected to take approximately 18 months.

Recently, the county board reconvened the FEA CCA task force for the purpose of reviewing the CCA design proposals. Approximately two meetings are anticipated this autumn. Meetings will be posted on the county website and announced in DRCA newsletters and to our email subscribers.

## Traffic Update

A brief update on traffic issues affecting the Donaldson Run neighborhood:

### Lorcom Lane:

New, smaller speed indicator signs were ordered and have been received. The county is waiting for Dominion Power to install the necessary power on the affected poles.

### Intersection of Vacation Lane and 23rd Street:

The county's analysis of this intersection indicated that it did not qualify for multi-way stop signs or other traffic calming measures.

### Intersection of Vacation and Lorcom Lanes:

Diagonal striping on the north side of Lorcom Lane was added at this intersection to allow cars to safely proceed further onto Lorcom Lane when making a left hand turn there. This has helped with the visibility problem, but concern has been expressed about the tailgating of drivers on Lorcom Lane who now have to slow down if someone is making a right turn here.

### Intersection of Vacation Lane and Taylor Street:

Jeff Sikes from the county's Transportation Division plans to evaluate this intersection with a county engineer.

### 26th -31st Street:

The county is considering a trial reconfiguration of the Vermont-26th Streets intersection by extending a curb to narrow the intersection and more clearly define the stop at Vermont Street. ## **NCAC Project Update**

The Donaldson Run Civic Association (DRCA) has four projects in the NCAC hopper. Here is an update on their status:

### **Project N349 – Donaldson Run Stream Restoration:**

See Larry Finch's article on page six of this newsletter.

### **Project N362 – Street Improvement on North Vermont Street:**

This project was funded in November of 2002 and had a projected completion date of November 2004, which will not be met. There has been a fifty percent design meeting with the neighbors and the project has just now completed the fifty percent plan stage. Additional refinements are required to bring the project to a ninety percent design stage at which time another meeting will be held with the neighbors. It may take approximately one year to reach this stage and, if all goes well, construction could start in the Spring of 2006.

### **Project N412 – Street Lights for Project N 362:□**

The large street improvement project for Vermont Street was broken up into two projects that will most likely be built at the same time. Project N412 is to install street lights along the improved section of Vermont Street and it shares in part of the design for project N362. Construction on this project may also begin in Spring of 2006.

### **Project N402 – Street Improvement on North 25th Road:**

Only survey work has been done on this project. The county is estimating that in 10 months they will have a fifty percent design completed so that a meeting can be scheduled with the neighborhood.

Portions of the stream restoration project may be completed by the end of this year, and over the next year DRCA can expect to participate in design meetings for the other three projects. The goal for completion of any NCAC project is 24 months. Unfortunately, it appears as if none of DRCA's projects will meet that goal. Updates will follow in future issues of this newsletter.
