## **Donaldson Run Stream Restoration**

Stream restoration work in Lee Heights Park is nearing completion. Earthmoving activity there was finished in September, and now park visitors can walk down to the stream at almost any point. Previously, access was difficult because erosion had resulted in steep banks several feet high along much of the stream.

Park visitors can see the measures that are being taken to control erosion and stabilize the stream. The new stream channel follows a series of gentle curves, and the banks have been laid back so that runoff can spread over a larger area during storms. In addition, stone structures have been built in the stream, creating "step pools" to help manage stormwater.

The restored stream has the characteristics of a natural stream channel: In rural areas, natural processes often produce streams with gentle curves and step pools. Restoration of Donaldson Run will result in a healthier stream, with a better environment for aquatic life and less silt being deposited in the Potomac River.

All that remains to be done in Lee Heights Park is to plant a variety of native trees and shrubs in areas

that were cleared for stream restoration. Planting is scheduled for late October, an ideal time for this activity.

Now stream restoration activity is shifting to the Zachary Taylor Nature Area. Work will progress downstream from North Utah Street to Military Road.

Earthmoving activity should be completed in January 2006. Erosion control fabric will be installed to stabilize the stream banks until vegetation becomes established. Trees and shrubs will be planted when the weather permits, probably in March.

The nature trail from Military Road to North Utah Street will be closed until the work is completed, and the bike path from Military Road to North Vermont Street may be closed for shorter periods.

We will miss the trees that are being lost in the stream restoration process, but next spring the newly planted trees will begin to grow into a forest that park visitors will enjoy for generations to come – a forest bordering a healthy, stable urban stream.

## Arlington Historical Society Meeting

The Arlington Historical Society will meet Tuesday, November 15, at 7:30 PM in the auditorium of the Arlington Central Library, 1015 North Quincy Street.

Virginia Mecklenburg, Senior Curator at the Smithsonian American Art Museum, will present a slide lecture on Auriel Bessemer and his Post Office Murals of the 1930s. Mr. Bessemer was commissioned by the Department of the Treasury's Section of Fine Art to paint murals for the new central post office in Clarendon.

The murals, entitled "Historical and Industrial Scenes - Sketches of Virginia", are on loan from the U.S. Postal Service to the library during the restoration of Arlington's Joseph L. ### Military Road

As you may remember from past articles, Military Road at 26<sup>th</sup> Street/Road near Taylor School has been identified by neighbors and the County as a problem area for pedestrians and drivers. For years, neighbors living on 26<sup>th</sup> Street have tried to draw attention to the hazards caused by fast traffic and poor visibility. Two traffic studies have recommended making changes to Military Road so that this area will be less dangerous for drivers and pedestrians. With that as background, the Donaldson Run Civic Association (DRCA) invited Dennis Leach, Arlington's Director of Transportation, to visit the intersection at 8:30 am on a Monday in September. Mr. Leach observed first hand the speed of rush hour traffic and heard reports from parents and the school crossing guard about the challenge of providing a safe crossing for children walking to Taylor School. Mr. Leach concurred that the area needed attention, and said that he would begin to focus county efforts on developing solutions and funding for this area. As a short term aid for drivers turning in and out of N. 26<sup>th</sup> Street, DRCA has asked the County to replace the parabolic mirror on Military Road. So far we have been unsuccessful in our request because mirrors are not in the County's "toolbox" of approved traffic techniques. Stay tuned for more information as we continue to focus on this part of Military Road.

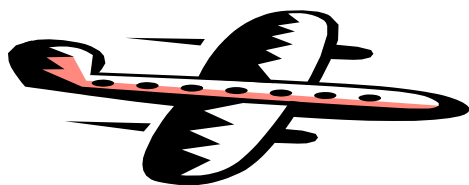
There are several things that you can do to protect yourself and your family:

# Airport Noise Study

Last year the Donaldson Run Civic Association was one of a number of civic associations in the Washington area that contributed to a region-wide study which made recommendations to mitigate aircraft noise from Reagan National Airport. Recommendation number one calls for aircraft to remain over the river from take off until reaching a point north of Langley, Virginia. The study is now wending its way through the Federal Aviation Administration (FAA) bureaucratic process. It has been reviewed by the FAA district office at Dulles and has been handed off to the FAA New York office, which is conducting a "pre-review." Once the "pre-review" is completed the study and recommendations will be published in the Federal Register and a 180-day public comment period will begin.



Whether any of the recommendations will be accepted remains to be seen. However, in the meantime, there is one bit of good news. Alaska Air is following recommendation number one by using the "way points" that mark the over-the-river flight-path. Alaska Air planes are equipped with global positioning systems (GPS) needed for many airports in Alaska. This will spare the FAA the cost of an expensive study to determine whether GPS is feasible for the Reagan National Airport flight-path.

## Neighborhood Conservation Update

Donaldson Run's Neighborhood Conservation (NC) plan (available on the web site [www.drca.org](http://www.drca.org)) was accepted by the Arlington County Board in 2000. Five years later, we have four NC projects working their way through the system and a few of them nearing completion.

**Stream Restoration:** As you read this newsletter, the stream restoration has been completed in Lee

Heights Park and work has begun at the Utah Street entrance to the Taylor Nature area. This project should be completed by early next year, and I believe it will be a model for other stream restoration efforts in Arlington. At our last meeting, the civic association agreed to ask the Neighborhood Conservation Advisory Committee to fund a design project for stream restoration of Tributary B from its confluence with the main stream all the way up to the mulch pile. Once we have the design completed, we then can ask for funding for construction projects to implement the design.

**Vermont Street:** While this project has not moved as fast as we would like, we have reached the 100 percent design phase through the efforts of block captain Julius Asboth. The County is going to review the project one more time in an effort to cut some costs and then it will put it out for bid. The timeframe for start of construction is March 2006. The streetlight component of this project would be done in tandem with the curb, gutter and sidewalk portion of the project.

**25th Road:** This project is scheduled to have a 75 percent meeting sometime in the near future. Block captain Tim Arthurs still has a few issues to work out with the affected neighbors before the project moves to the 100 percent design phase. Given that, it is anticipated that construction on this project will start sometime in late 2006.

## Update on 26<sup>th</sup> Street Sidewalk

By the time you read this, work may have started on a new sidewalk on N. 26<sup>th</sup> Street between Wakefield and Upland Streets. Neighbors' questions and concerns were addressed at a meeting in early October, and those attending were advised that construction could begin by the end of the month. Surveyors have been spotted on the street, and it appears that the project will begin very soon. This project will serve three purposes: 1) enhance pedestrian safety, 2) solve a drainage problem at the intersection of Vermont and 26<sup>th</sup> Streets, and 3) hopefully calm traffic in that area. County staff worked closely with the neighbors to resolve several important concerns, and the interest and involvement of those who live in the area made this a better project. Thanks to those of you who were involved and to County staff for their persistent effort. # DRCA Rises to the Challenge

The Donaldson Run neighborhood has met the challenge and is officially wildlife friendly!

Since the beginning of 2005, a dozen DRCA neighbors have responded to the National Wildlife Federation's Community Wildlife Habitat Neighborhood Challenge by certifying their properties as Backyard Wildlife Habitats. To have a certified Backyard Wildlife Habitat, a homeowner must have a property that provides food, water, shelter, and a place to raise young. DRCA was one of only a few Arlington civic associations that answered the challenge—to certify at least five new properties by September 30—and will receive recognition from the Arlington County Board at a special ceremony on Wednesday, November 9, at the Historic Hendry House at Ft. C.F. Smith, 2411 North 24th Street.

Why is does Zachary Taylor figure so prominently in our neighborhood, having both a park and school named after him?

Dear Curious,

I was able to uncover a bit of information about the naming of Zachary Taylor School, which opened in 1953. In the 1950's, schools were often named for famous people or places in Virginia such as Williamsburg, Yorktown, and Washington-Lee. Interestingly, Taylor School was first named after Taylor Street which is near the school. Zachary was added to the official name of the school in 1969. Zachary Taylor, who was born in Orange County, Virginia, was President of the United States for only one year. He died in office on July 9, 1850, reportedly after getting sick from eating cherries at a July 4 celebration. By the way, the cost of building Taylor School was \$542,000.

## Saving Trees from English Ivy

This is a good season to work on the English ivy growing in our yards. If not controlled, it will spread across the yard, choking out other plants. Saving trees should be the top priority. When ivy covers the trunk of a tree, it traps moisture and softens the bark, reducing the tree's defenses against insects and disease. Eventually, it blocks sunlight from the leaves and kills the tree.

Ivy can be removed from trees by pulling it away from the trunk and cutting it at shoulder level and near the ground, creating an ivy-free band around the tree. There is no need to pull ivy down from higher up in the tree; it will die anyway, and removing it may damage the tree.

Eliminating ivy from the area around trees also is important. Ivy competes with trees for water and nutrients. Trees will be healthier if the ivy is removed from the root area and replaced with a thin layer of mulch.

After rescuing the trees, the next step is to begin eliminating ivy from our yards. It has a shallow root system that is not effective in controlling erosion, and it provides a favorable environment for undesirable wildlife, including mosquitoes.

A variety of non-invasive ground covers are available to replace English ivy. Some examples are listed in the booklet, "Native Alternatives to English Ivy", available from the Virginia Cooperative Extension (703-228-6521).



## Arlington Seeking Ham Radio Operators

Katrina, Rita, Wilma.... As this year's active hurricane season has shown us, emergency communications are vital during a disaster. That's why Arlington is looking for new volunteers for its Radio Amateur Civil Emergency Service (RACES).

"As Hurricane Katrina proved, natural or manmade disasters can knock out phone lines, and leave even cellular networks inoperable [or] jammed," said David Jordan, Arlington's RACES officer and the County's chief information security and privacy officer. "If Arlington County's emergency communications systems were damaged in a disaster, that's when RACES volunteers would spring into action."

As the County's RACES officer, Jordan is charged with identifying, recruiting and training FCC-licensed amateur radio - a.k.a Ham - operators. RACES volunteers must be willing to:

- Become competent in providing auxiliary emergency communications, anytime, anywhere;
- Maintain proficiency through continuing education, drills and exercises, and
- Serve in their community and perhaps throughout the Commonwealth during emergencies and disasters.

Typical RACES communications involve sending and receiving emergency messages on Amateur Radio Service frequencies between critical government offices, Emergency Operations Centers (state, county, local) and other locations such as hospitals, emergency services, emergency shelters and other locations where communication is needed.

Arlington County began its annual fall leaf collection program on October 31. Leaves will be vacuumed from curbside in each Arlington Civic Association, although the exact schedule for DRCA was not available at press time. Look for leaf collection schedules to be posted throughout the neighborhood within the next several weeks.

For residents who prefer to bag their leaves, the County has free biodegradable bags—which are collected one business day after the regular trash pick-up—at the following nearby locations:
